## Part 1 Seller Agreement

This puppy is named

- 1.1 This puppy is of typical temperament and structure and embodies the basic standards of the Japanese Akita.
- 1.2 All puppies have passed their initial health examination performed by a licensed veterinarian at Ashcott Animal Clinic, and received their first shot of vaccinations (DHPP), and the record will be provided to the buyer.
- 1.3 It is still recommended that the buyer to take the puppy to be seen by a licensed veterinarian in order to initiate a 6-8 week free insurance coverage.

- 1.4 If the veterinarian declares the puppy unwell or unsound therefore fails the Initial Health Examination, the purchase price of this puppy will be refunded to the Buyer. The Buyer will NOT be responsible for veterinary or shipping costs.
- 1.5 If the puppy is diagnosed with congenital diseases within one year with documents presented by professional Veterinarian, Seller will provide another puppy in same breed for free. (Cryptorchidism in male dogs is not covered; typical breed defects of toy poodle such as patellar luxation is also not covered)
- 1.6 Shall the owner decides to abandon / re-home the dog (described blew) after the purchase is complete, our kennel is committed to assist the owner finding a new home for the dog to the best extent possible. In case of a desirable new home is not available within the owner's timeline, our kennel is willingly intake the dog after the owner agrees and releases the dog back to the kennel. And the kennel will be responsible for the dog's lifetime well being.
